





## Activities and Projects

1. Sponsorship and launch of the "Best practices of handling - in the corral" guidebook in partnership with the Etco Group (Animal Ecology and Etiology Study and Research Group) and the Unesp (State University of São Paulo) campus in Jaboticabal, São Paulo. The company printed 20 thousand copies of the guide's first edition for distribution to the company's cattle suppliers.

2. Delivery of 20 thousand animal welfare kits to cattle suppliers. The kits include handling flags, a poster and an illustrated booklet with guidelines to facilitate cattle ranching. <u>Click here to watch the campaign video</u>.

3. 36 Friboi plants (100% of plants in 2019) have once again obtained the JBS Supply Chain Protocol certification, confirming their commitment to the certification guidelines that ensure food safety, traceability processes and, more importantly, high animal welfare standards.

## Activities and Projects

4. PAACO (Professional Animal Auditor Certification Organization) Certification for 15 Friboi plants, including 10 renewals and 5 new certifications.

5. Employee training in Goiânia, Senador Canedo and Mozarlândia, plants in the state of Goiás, administered by international guest and global expert Erika Voogd, in partnership with the Certified Humane Institute.

6. Friboi is presented as a success case and is the only Brazilian company cited in the beef cattle chapter of the book entitled "Animal Welfare in Brazil and Germany", released by the Brazil-Germany Chamber of Commerce and Industry.

7. We introduced a security camera implementation project to remotely monitor the work in corral at JBS feedlots.

8. American researcher and global expert Temple Grandin visited JBS unit II in Campo Grande/MS to speak to the team about the importance of animal welfare in the protein production industry.
