



Responsible Purchasing Policy of JBS Friboi - Suppliers

RECIPIENTS: Cattle suppliers, employees, and third parties acting on behalf of Friboi in operations related to cattle procurement.

1. OBJECTIVE

To inform about JBS Friboi commitment to responsible purchasing of raw materials.

2. RESPONSIBILITY FOR COMPLIANCE

All departments involved in the process and mentioned in this document are responsible for complying with this regulatory instruction.

3. GENERAL PROVISIONS

- 3.1. JBS Brazil has a responsible purchasing policies for raw materials that establishes social and environmental criteria for the selection of suppliers;
- 3.2. Friboi, JBS' beef business in Brazil, does not acquire animals from farms or suppliers involved in:
 - Deforestation in the Amazon biome, with or without authorization, with cut-off date of 07/22/2008;
 - Unauthorized deforestation in the other biomes, with cut-off dates of 08/01/2019;
 - Areas that overlap with Indigenous lands;
 - Areas that overlap with Quilombola territories;
 - Areas that overlap with Environmental Conservation Units,
 - Areas embargoed due to deforestation;
 - Slave-like working conditions;
 - High-risk crimes;
 - Reputational risks to JBS.
- 3.3. The concept and the source of the deforestation data used by JBS come from the Amazon and Other Biomes Monitoring Program (PAMZ+), of the National Institute for Space Research (INPE);
- 3.4. To ensure that the purchase of animals meets the established social and environmental criteria, since 2010 Friboi has processes to verify and monitor the condition of the farms of all its direct suppliers. The processes rely on a system that uses satellite images, georeferenced data, and lists of information from government agencies as the basis for the daily analysis of all farms and livestock suppliers of the company. Only registrations that meet the Purchasing Policies are eligible to do business with JBS;
- 3.5. The company's livestock purchasing operations and supplier monitoring system are independently audited annually and the results of the audits are published on JBS' website;
- 3.6. To bring socio-environmental management and control to the suppliers that make up the production chain of suppliers contracted by JBS, Friboi has the Transparent Livestock Platform (PPT). The PPT is a free tool that allows any livestock farmer to register and verify the socio-environmental compliance of their own suppliers, providing free access to technologies and supplier management tools for others in the livestock production chain. The platform was developed with blockchain technology, ensuring data security and privacy. As of 2026, JBS will not buy from producers that are not registered on this platform;
